# WHY?


- > VPD Study (2007) "Lost in Transition".
- Mental Health was found to be a factor in 31% of calls, and as a high as 50% in some areas.
- Economic analysis of VPD statistics suggested that police time spent attending calls where mental health was a factor is equivalent to 90-full time police officers, at an annual cost of \$9 million.
- Police have become mental health workers.

The MHO position was established in January 2016 in response to the mental health crisis.

# PRIMARY ROLES

- Monitor clients in the community, who as a result of MH, have excessive or high risk contact with police.
- Collaborate with MH teams, health authorities, community partners, Crown Counsel and probation to develop care plans and strategies to reduce crisis.
- Offer crisis support to patrol members.
- Coordinate MH follow-ups and outreach using a clientcentered, harm reduction approach.

# CASE STUDY - BACKGROUND

- 47-year-old homeless male (lives in a tent in a forested area off Highway 1 in Burnaby).
- History of trauma, depression, suicidal ideation and severe alcoholism (24-48 beers per day).
- Becomes acutely suicidal when intoxicated.
- 911 Response: Client is known to evade police and will attempt to get hit by a vehicle when suicidal.
- Substantial police resources utilized.
- Discharged from hospital when sober.



# CASE STUDY INCIDENT

- June 2017: Male reported missing with suicidal ideation being expressed to a crisis line on the day previous.
- Transit Police locate male intoxicated on the Skytrain.
- Male advised of intake appointment at Creekside Withdrawal Management Centre on the following day.
- Barriers expressed in attending appointment due to homelessness (eg. storage of belongings, transportation).
- Mistrust of police and fear of being arrested for intoxication in a public place.




# MHO INTERVENTIONS

- > MHO took custody of the male from Transit Police.
  - A plan was devised to transport the male and his belongings to a local shelter who agreed to store the male's possessions and allow him to sleep overnight.
- Transport was provided the following day to Creekside.
- Prevention and Management of Relapse:
  - Connected to A&D Counsellor.
  - Bi-monthly outreach visits and weekly telephone care
  - Housed, employed PT, and receiving PWD.
  - Detox / Rehab referrals when required.

First Nations Policing Program in collaboration with Public Safety Canada.



#### Meeting with former Governance Committee Chair

#### **Governance Policy Manual Review**

As required in our terms of reference, we need to complete an annual review of the manual for the period October 2017 to October 2018. We need to review (if any) any new policies added, revised or removed.

We noted that revisions have been made by the Human Resources Committee to the Chief Constable's Annual Performance Evaluation. The division into two separate processes is a positive step that adds clarity and lessens the strong prescriptive focus of the existing document.

We also note that the Human Resources Committee had requested that the Committee be allowed to determine who is included for the in-person and survey interviews each year.

Strategic Planning Process to be determined by June 30th, 2019 in order to be ready for September - October preparation of the Plan. A budget needs to be determined for the Strategic Plan and to determine if we are able to hire an external consultant via RFP.
